## Executive summary

The Council forward work programme for 2016 has been developed to reflect Council's priorities in support of the GMC's Corporate Strategy, the proposed Business Plan for 2016 and to enable the effective conduct of its work. The proposed work programme may be subject to change given the scale of changes associated with the Change Programme and the need to keep work under review to reflect priorities.

Council needs to consider the proposed work programme and decide whether any changes need to be made.

- 1** Council's work programme for 2016, at [Annex A](#), has been derived from ongoing and new work arising from the Corporate Strategy, Equality and Diversity Strategy, 2015/16 Business Plans, and Council corporate governance responsibilities, and reflects Council's priorities and issues which flow from its strategic aims for consideration.
- 2** In 2016 the priorities are:
  - a** Develop the Register and deliver Data Strategy Phase 2.
  - b** Revalidation review.
  - c** Speeding up fitness to practise procedures.
  - d** Supporting doctors, patients and relatives involved in fitness to practise investigations.
  - e** Taking forward legislative reform/the legislative programme arising from the Law Commissions' report.
  - f** Communications strategy and engagement.
  - g** Fairness and proportionality.
  - h** Respond to the Shape of Training review.
  - i** UK Medical Licensing Assessment.
  - j** Implementation of the Change Programme.
  - k** Understand the context in which doctors practise.
- 3** The work programme reflects the anticipated timetable associated with issues requiring reporting to or consideration by Council, and may be subject to further changes as priorities change, as new issues arise, or because of external factors which impact on the work. It takes account of securing Council's input at an early, interim and end stage to inform key strategic and high level policy issues.
- 4** The work programme will be further developed following ongoing work to review and finalise Directorates' Operational Plans, and the executive Boards' forward work programmes for 2016, including to consider the impact of the Change Programme on planned programmes of work. This work is being undertaken in parallel with the final stage of work to complete the 2016 Business Plan and Budget, which is on the agenda for Council's approval at this meeting ([agenda item 7](#)). Subject to Council's

consideration of these issues, the work programme for 2016 will be updated and included on the agenda for the Council meeting on 24 February 2016.

- 5** The work programme is kept under review by the Chair of Council and Executive and Council will be informed of any substantive changes as part of the agenda updates circulated between meetings as required.
