Undertakings on the registrant's registration

From 23 Aug 2013 to 09 Jun 2024

1. To contact the GMC within 7 days of his return to the UK. For confirmation, the following undertakings can only be fulfilled in the UK and the monitoring of his compliance with these undertakings will start from the date of his return.
2. To notify the GMC promptly of any post he accepts which registration with the GMC is required and provide the GMC with the contact details of his employer.
3. At any time that he is providing medical services, which require him to be registered with the GMC, to agree to the appointment of a workplace reporter nominated by his employer, or contracting body, and approved by the GMC.
4. To allow the GMC to exchange information with his employer, or any contracting body for which he provides medical services.
5. To inform the GMC of any formal disciplinary proceedings taken against him, from the date of giving these undertakings.
6. To inform the GMC if he applies for medical employment outside the UK.
7. To obtain the approval of his medical supervisor before accepting any post for which registration with the GMC is required.
8. To keep his professional commitments under review and limit his medical practice in accordance with his medical supervisor's advice
9. To cease work immediately if his medical supervisor advises him to do so.
10. To confine his medical practice to posts within the National Health Service and not undertake any private practice.
11. Not to undertake any locum posts of less than 1 month duration.
12. To inform the following parties that his registration is subject to the undertakings, listed at (1) to (11), above:
 - a. Any organisation or person employing or contracting with him to undertake medical work
 - b. Any locum agency or out-of-hours service he is registered with or apply to be registered with (at the time of application)
 - c. In the case of locum appointments, his immediate line manager at his place of work (at least 24 hours before starting work)
 - d. Any prospective employer or contracting body (at the time of application)
13. To permit the GMC to disclose the above undertakings to any person requesting information about his registration status.
