On 8 July 2024 Dr Hyder was convicted of the assault of Mr A by beating him on 21 April 2024, contrary to section 39 of the Criminal Justice Act 1988, and subsequently fined £2720.00. This behaviour does not meet with the standards required of a doctor. It risks bringing the profession into disrepute and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: Dr Hyder must make sure that his conduct justifies patients' trust in him and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on your registration, it is necessary in response to issue this formal warning.
