On 4 November 2024, Dr Gibson was found to be in possession of cannabis, for which he accepted a Community Resolution Order. On 12 June 2025 Dr Gibson was convicted of driving a motor vehicle on 4 November 2024 with the proportion of a specified controlled drug, namely cannabis, above the specified limited. This behaviour does not meet with the standards required of a doctor. It risks bringing the profession into disrepute and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81. You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Gibson's registration, it is necessary in response to issue this formal warning.
