On 14 January 2025 Dr Wang received a police conditional caution for stealing a watch, on 18 October 2024, to the value of £600.00 belonging to Decathlon Ltd contrary to section 1(1) and 7 of the Theft Act 1968. This conduct does not meet with the standards required of a doctor. It risks undermining public protection, specifically public confidence in the profession and professional standards and conduct and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81. You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Wang's registration, it is necessary in response to issue this formal warning.
