On 27 November 2025 Mr Giordano was convicted of driving a motor vehicle whilst having a proportion of alcohol in their system above the prescribed limit. This behaviour does not meet with the standards required of a doctor. It risks undermining public protection, specifically public confidence in the profession and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Mr Giordano's registration, it is necessary in response to issue this formal warning.
