On 17 August 2024, at a social event, Dr Bakr was found by the police to be in possession of cannabis resin and was served with a community resolution disposal record for the offence. This conduct does not meet with the standards required of a doctor. It risks bringing the profession into disrepute and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81 You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Bakr's registration, it is necessary in response to issue this formal warning.
