The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81. Whilst this failing in itself is not so serious as to require any restriction on Dr Dickson's registration, it is necessary in response to issue this formal warning.
