'On 22 June 2025, Dr Damree attempted to prescribe medication for herself without holding a valid licence to practice. This conduct does not meet with the standards required of a doctor. It risks bringing the profession into disrepute and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraphs 4 and 81 are particularly relevant: 4. You must follow the law, our guidance on professional standards, and other regulations relevant to your work. 81. You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Damree's registration, it is necessary in response to issue this formal warning. This warning will be published on the medical register in line with our publication and disclosure policy, which can be found at www.gmc-uk.org/disclosurepolicy.'
