On 7 June 2025 Dr Adeluwoye was convicted of using a motor vehicle without third party insurance, contrary to Section 143 of the Road Traffic Act 1988 and Schedule 2 to the Road Traffic Offenders Act 1988, and driving a motor vehicle without a licence authorising Dr Adeluwoye to drive a motor vehicle of that class, contrary to Section 87(1) of the Road Traffic Act 1988 and Schedule 2 to the Road Traffic Offenders Act 1988. This behaviour does not meet with the standards required of a doctor. It risks bringing the profession into disrepute and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81. You must make sure that your conduct justifies patients' trust in you and the public's trust in the profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Adeluwoye's registration, it is necessary in response to issue this formal warning.
