On 20 November 2024, the Dr sent a WhatsApp message to a woman that was threatening and abusive. This conduct does not meet with the standards required of a doctor. It risks undermining public protection, specifically public confidence in the profession and the professional standards and conduct expected of a doctor and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, paragraph 81 of Good medical practice is particularly relevant: 81. Dr Ajala must make sure that his conduct justifies patients' trust in him and the public's trust in his profession. Whilst this failing in itself is not so serious as to require any restriction on his registration, it is necessary in response to issue this formal warning.
