On 21 May 2025 Dr Morse was convicted of stalking involving serious alarm/distress and he was sentenced to a community order, a restraining order and to complete 200 hours of unpaid work. This conduct does not meet with the standards required of a doctor. It risks undermining public protection, specifically public confidence in the profession and professional standards and conduct and it must not be repeated. The required standards are set out in Good medical practice and associated guidance. In this case, the following paragraph of Good medical practice is particularly relevant: 81. You must make sure that your conduct justifies patients' trust in you and the public's trust in your profession. Whilst this failing in itself is not so serious as to require any restriction on Dr Morse's registration, it is necessary in response to issue this formal warning.
