

Income Discount Application

The income discount provides a 50% discount on your annual fee. Before applying please read the guidance on our webpage www.gmc-uk.org/incomediscount

You are eligible to apply if:

- You're registered with or without a licence to practise,
- You pay a fee that has not already been discounted,
- Your gross income from all sources during your registration year is less than the threshold.

Until 31 March 2025 **£36,000**

1 April 2025 to 31 March 2026 **£37,000**

From 1 April 2026 **£38,500**

Evidence of income

We routinely audit applications and so we may ask you for evidence of your income. It is important you are able to provide this to support your application for the discount. For more information visit www.gmc-uk.org/evidenceofincome

Calculating income

Calculate your gross annual worldwide income for your registration year. For example:

Fee due 1 August Applying for 2025-2026

Your income between 1 August 2025 and 31 July 2026 should be below £37,000

Fee due 1 April Applying for 2026-2027

Your income between 1 April 2026 and 31 March 2027 should be below £38,500

What happens next?

Return the form by post or email to the address above. We'll process your application within five days of receiving it.

If you pay by Direct Debit we will send you an updated payment plan once the discount has been applied. If you are due a refund we will refund directly to the account used to pay your fee.

If you pay by another method we'll send you an email or letter advising you when your balance has updated. Alternatively, you can check whether the discount has been applied by logging into GMC Online. If you are due a refund and paid by card, we'll refund directly back to the card used to pay your fee. If you paid using another method, please request a refund directly to your bank account by completing a bank nomination form: www.gmc-uk.org/nominated-bank

If you're applying for a future period before you have been billed, the discount will be applied to your upcoming bill.
